- HOW TO REACH US

By car: From the north: motorway A3 Salerno Reggio Calabria (Lagonegro north exit) continue to Valle del Noce towards road SS 18 to Diamante; From the south: motorway exit to Falerna continue to SS18 Diamante (Diamante south exit). **By train**: arriving at the station of Diamante-Buonvicino; **By plane**: arriving at the international airport of Lamezia Terme. (free transfer arranged by the hotel, for and through the train station of Diamante-Buonvicino)

- CHECK IN e CHECK OUT

The room is available from **02:00 pm**, and the day of departure is necessary to leave it not later than **10:00 am**. Tourist tax.

On 1 January 2013 the municipality of Diamante has established a tourist tax. The tourist tax relates to overnight in the period between June 21 and September 21 of each calendar year, it is applied at the facilities located in the municipality of Diamante up to a maximum of seven consecutive nights in the same accommodation. The fee for each overnight stay is 1.50 Euro.

Are exempt from the tax, the following persons: a) Who is registered and resident in the municipality of Diamante; b) Those that the day of the check-in have not yet reached sixteen years of age and those who have more than seventy years of age; c) Those who stay for study or those employed in the public administration or who are employed by contractors for works, services or supplies of public administration. d) Emigrants who return for the holidays, as well as abroad; e) Guests, institutional or civilians whose stay is paid by the municipality of Diamante; f) Disabled person whose disability is not serious and without a carer; g) Disabled with severe disabilities ccompanied by a carer L.104/1992; h) Exhibitors who participate in events sponsored by the Municipality of Diamante; i) Volunteers committed to Social Service during events organized by the Local Authority or volunteers who are active during the civil protection emergencies in the Municipality of Diamante; I) An exemption from the tax is applied to each bus driver and tour guide, in groups organized by travel or tourism agencies, which include a minimum of 25 tourists; m) Those that are part of the Public Security, Public Authority or Local Authority including the National Fire Brigade that, for reasons of service sometimes of temporary type, stay in accommodation facilities in the municipality of Diamante; n) All employees who stay in their accommodation for tasks like working; o) Those who, as escorts for patients, assist patients hospitalized at Public Health Facilities on the surrounding area within 25 km from the borders of the Town of Diamante.
